No. SEC. 1096/CR-34/96/PR.—In exercise of the powers conferred by clause (1) of Article 243-K of the Constitution of India, read with sub-sections (2) and (4) of section 9A of the Maharashtra Zilla Parishads and Panchayat Samitis Act, 1961 (Mah, V of 1962) (hereinafter referred to as "the said Act") and of all other powers enabling me in this behalf, I, D. N. Chaudhari, State Election Commissioner, Maharashtra, hereby:

(a) delegate the powers under section, sub-sections and clauses of the said Act and of the rules, sub-rules and clauses of the Maharashtra Zilla Parishads Election Rules, 1962 and Maharashtra Panchayat Samitis Election Rules, 1962, as the case may be, for the purpose and to the extent specified in clolumn (2) of the Schedule hereto, to the officers of the State Government as shown against each of them in column (3) of the sais Schedule;

(b) direct that these officers shall exercise these powers subject to my supreintendence, direction and control and without prejudice to the provisions of sub-section (4) of section

9A of the said Act.

2. In exercise the powers as aforesaid, the officer concerned shall, wherever necessary, sendreports in respect thereof to, endorse copies of various notices, forms and communications to, and, obtain directions and approval of the State Election commissioner.
